

# 攝影愛好者之認真休閒特質、休閒涉入與其尋求休閒利益關係之探討

## 摘要

本研究旨在探討：(1)不同背景特性之攝影愛好者在其認真休閒特質、休閒涉入及休閒利益上有無顯著差異。(2)攝影愛好者之認真休閒特質、休閒涉入及休閒利益之相關程度。本研究採立意與便利抽樣方式選取樣本，以中部三縣市攝影組織會員為對象，共發放問卷420份，取得有效問卷計375份。研究結果發現：(1)不同「性別」、「每月可支配所得」之攝影愛好者，在認真休閒特質上有顯著差異。(2)不同「性別」、「年齡」之攝影愛好者，在休閒涉入上有顯著差異。(3)不同「性別」、「年齡」、「教育程度」及「婚姻狀況」之攝影愛好者，在休閒利益上有顯著差異。(4)認真休閒特質與其休閒涉入中之社會心理涉入呈現顯著正相關；與休閒涉入中之行為涉入大部分呈現顯著正相關。(5)認真休閒特質與其休閒利益呈現顯著正相關。(6)休閒涉入中之社會心理涉入與其休閒利益呈現顯著正相關；休閒涉入中之行為涉入與其休閒利益大部分呈現顯著正相關。(7)獨特的精神、認同感、持久利益、堅持不懈、吸引力、生活型態中心性對休閒利益具有顯著正向的預測力，其中以獨特的精神預測力最強。
