The methodology of this thesis in utilized interview and questionnaire with accountants, and we got 173 questionnaires from Deloitte, HLB International (Candor Taiwan CPAs) and Taipei Certified Public Bookkeeper association. The our research found that relation of the political behavior with Independence、Expertise、Power and Promotion .According to the result of our research, we explain the relation variability to discuss the relation of the political behavior with Independence、Expertise、Power and Promotion .
