

# 客戶信任對審計品質之影響

## 摘要

本研究主旨是探討客戶信任與審計品質之間的相關性。透過台灣國內會計事務所之會計人員277份問卷與其客戶252份問卷進行分析。研究方法使用信度分析、相關分析、迴歸分析等方法。研究結果顯示，客戶信任對審計品質的代理變數事務所規模大小、會計師任期，皆具有正向顯著關係。根據研究結果，進一步提出研究限制與建議。
