ABSTRACT

This study will attempt, through the degree of maturity in organizational structure of the Taiwan chapters of those known international social welfare organizations, to evaluate the overall characteristics of our domestic social entities, its characteristics and its business strategy as well as how their leader has affected the growth of this entity by way of their own special personal quality. The purpose is to study the mode of activities and their growth and continual development through the business strategy which this organization has adopted. The study did discover the following: 1. The Taiwan chapter of the international organizations do have a well structured organizational set, it is far more mature than others, very much similar to a well run business entity with relationship very much like local branch office vs. main office. Its overall businesses are well targeted with requirements well defined. This certainly help in their overall organization. 2.Persons in charge of different business aspects are obtained through elections, this help in democratic society. The running of business also help the personal achievement through daily planning and execution of activities of the organization hence enabling the social functions ability of this person. 3. The local chapters of Individual organization, carrying out their own activities as planned by their main offices. This resulted in an effect very similar to a cartel or syndicate organization in feeding back to the society thus consolidated the resources and become a special force towards the society they intended to serve. 4. The entities tend to compete with each other even though they are of non-profit seeking nature. The public regard their joining into an entity a pride when such entity have offered a good variety of services to the society. 5.A business entity leader would determine the special characteristics of his company based on his own advantageous points, this is not so recognized when come to Non-profit Seeking organizations due to the fact that their leaders usually do not selected to seat on that position long enough to affect the running of the entities.
