

# A Study of the Relationships among Human Resource Practices, Psychological Contract, Knowledge Sharing Innovation- A ...

## ABSTRACT

This research discusses the relationships among human resource practices, psychological contract, knowledge sharing and innovation in Combined Logistics Command. The study is conducted with a questionnaire survey, sampling population of members in Combined Logistics Command. 580 members were requested to answer the questionnaire. And the effective respondents were 445. The research uses descriptive statistics, multi-variation variables analysis, hierarchical regression analysis and various statistics tests to verify study assumptions and to interpret the result of study.
