ABSTRACT

The Influence of Adventure Education on Employees' Teamwork Efficiency - Example of the Y Hightech Companyin Changhua County Student: :Kuei-Chu Teng Advisor: Prof . Wei-Ling Lee Da-Yeh University ABSTRACT This dissertation studies the influence of adventure education on employees ' teamwork efficiency, with a view to finding out the connections between adventure education and teamwork efficiency while also providing a company ' s management and manpower resources unit with feasible ways to enhance the communication, coopera-tion, division of work, problem-solving and policy-making in teamwork. Middle-level executives of the Y environmental protection company of Changhua County in central Taiwan have been chosen as research objects, and a total of 32 persons are selected as effective samples. This research adopts the " pretest-posttest control group design model " of the Quasi-Experimental Designs, while makes use of SPSS windows 10.0 Chinese version and t-test, one-way ANOVA, and paired-t to conduct statistical analyses. The following results have been achieved: The Experiment Group, after taking part in adventure education activities, has shown significant difference between the Control Group in terms of teamwork effi-ciency, communication, cooperation, division of work, problem-solving and pol-icy-making. Participating members in the Experiment Group have demonstrated different per-formance before and after these adventure education activities. The characteristics of those participants in the Experiment Group, in the pretests and posttests, show no significant differences in terms of teamwork efficiency, commu-nication, cooperation, division of work, problem-solving and policy-making. Only the " gender " factor shows some differences in team cooperation and division of work. In the end, a general discussion is conducted regarding research results and some concrete suggestions are made for the reference of related agencies or interested re-searchers in future.
