摘要

越南政府在執行環境影響評估制度15年後,2005年11月制定了「環境保護法」,以補強「政策環境評估」與「環境影響評估」相關條文。「環境保護法」是越南環境管理的一項重大成就,然而環境影響評估執行成效仍難令人滿意。 本研究採用Wood 14項準則評估越南環境影響評估制度。這些準則聚焦於環境影響評估的需求與運作。本研究就開發中國

家越南的環境影響評估制度,與已開發國家的美國與即將進入已開發國家的台灣進行比較,以探討改善之道。

現行越南環境影響評估制度之缺失包括法律架構的鬆散、累積影響與替代方案評估的欠缺、範疇界定的不足、有效公共參與的缺乏。

本研究藉由先進國家立法經驗,指出越南可以強化其環境影響評估制度的機會。
